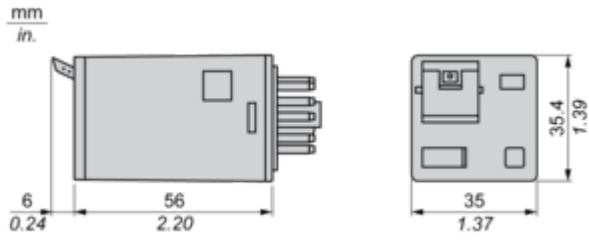

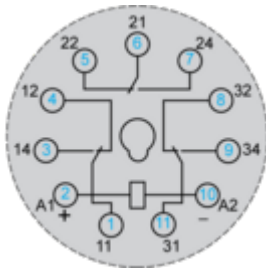
Wiring Diagram

**Electrical Durability of Contacts**

---

Durability (inductive load) = durability (resistive load) x reduction coefficient.

Resistive AC load



X Switching capacity (kVA)

Y Durability (Number of operating cycles)

Reduction coefficient for inductive AC load (depending on power factor cos φ)



Y Reduction coefficient (A)

Maximum switching capacity on resistive DC load



X Voltage DC

Y Current DC
